## 2024 SCHOOL TRUSTEE BY-ELECTION NOTICE OF NOMINATION

**PUBLIC NOTICE** is given to the electors of Coast Mountains School District 82 that a School Trustee By-Election will be held to elect one School Trustee for Trustee Electoral Area 1 (Kitimat) for a term commencing January 2025 and ending in November 2026:

Originals of the emailed nomination documents must be received by the Chief Election Officer by 4:30 p.m. on Friday, November 8, 2024.

**QUALIFICATIONS:** A person is qualified to be nominated, elected, and to hold office as a School Trustee if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day December 7, 2024;
- resident of British Columbia for at least six months immediately before the day nomination papers are filed;
- not disqualified by the *School Act* or any other enactment from being nominated for, being elected to or holding the office, or be otherwise disqualified by law.
