#### **POLICY STATEMENT**

The Board strives to develop positive and welcoming school cultures and is committed to fostering optimal environments for learning. The Board shares a commitment with its communities to maintaining safe, caring, and orderly schools for students, staff, and community.

# **RATIONALE**

This policy is developed to recognize that a student's ability to learn is strongly affected by his or her sense of safety and belonging. The Board is committed to creating and maintaining school environments that support student achievement and a sense of well-being by addressing safety issues that can become barriers to learning. In agreement with the Ministry document, *Developing and Reviewing Codes of Conduct*, the Board believes that:

- Safe schools make it easy and safe for students and their parents to inform school authorities of safety concerns. They recognize the extreme importance of addressing instances of bullying, harassment, and intimidation.
- Caring schools enable parents to advocate for their children's well-being, enable students to help each other, and promote appropriate adult-student relationships.
- Orderly schools plan for things to go right and are ready to respond appropriately if or when things go wrong, minimize distractions from purposeful learning activities, and are characterized by a climate of mutual respect and responsibility.

## **POLICY**

The Board is committed to maintaining safe, caring, and orderly schools. The Board will foster and maintain effective measures to deal with potentially unsafe situations in the schools. In accordance with government policies and guidelines, the Board will strive to ensure that each school will:

- develop positive school cultures that focus on prevention
- use school-wide efforts to build community, fostering respect, inclusion, fairness, and equity
- set, communicate, and consistently reinforce clear expectations of conduct
- teach, model, and encourage socially responsible behaviours that contribute to the school community, solve problems in peaceful ways, value diversity, and defend human rights
- assume responsibility, in partnership with the wider community, for resolving critical safety concerns
- work together to better understand issues such as bullying, intimidation and harassment, racism, sexism and homophobia, and to learn new skills to respond to them
- respond consistently to incidents in a fair and reasoned manner, using interventions that repair harm, strengthen relationships, and restore a sense of belonging
- participate in the development of policies, procedures, and practices that promote school safety
- monitor and evaluate school environments for evidence of continuous improvement
- recognize and celebrate achievements, while acknowledging areas that need improvement.
